RESOLUTION ---- ESTABLISHING CONNECTION DATE AND SEWER SERVICE RATES FOR THE WIGHTMAN'S GROVE SANITARY SEWER IMPROVEMENT – CONTRACT A OF THE GENERAL SEWER DISTRICT.

The Board of County Commissioners, Sandusky County, Ohio, met in regular session the 24th day of February, 2022, at the office of the Board with the following members present:

Commissioner Schwochow moved the adoption of the following resolution:

Whereas, Steven F. Shiets, P.E., Sandusky County Sanitary Engineer, is recommending connections for the Wightman's Grove Sanitary Sewer Improvement – Contract A start on March 1, 2022 and that the Sanitary Sewer Service Rates for the Wightman's Grove Area of the General Sewer District per Equivalent Single Family Unit (ESFU) be established on April 1, 2022 to include any new connections utilizing the Wightman's Grove Sanitary Sewer Improvements – Contract A for the charges outlined below to be collected by the Sandusky County Sanitary Engineers Office.

THEREFORE: Be It Resolved;

Section 1: The Wightman's Grove Sanitary Sewer Improvement – Contract A (Wightman's Grove Area) for the General Sewer District is ready for new connections effective March 1, 2022. All connections shall be completed within one-hundred and twenty (120) days from March 1, 2022. There is currently no connection charge for this area within the General Sewer District.

Section 2: The Wightman's Grove Sanitary Sewer Improvement – Contract A (Wightman's Grove Area) Sanitary Sewer Service Rates for the General Sewer District per Equivalent Single Family Unit (ESFU) as described above shall be as set forth as follows for new connections effective April 1, 2022:

Lift Station Operation, Maintenance & Rehabilitation (WGO)	\$7.00
Lift Station Construction Debt (Contract A) (WGD)	\$24.00
Wastewater Plant Operation, Maintenance & Rehabilitation (EHO)	\$28.00
Wastewater Plant Construction Debt (Contract B) (EHD)\$46.00	
Total Monthly Charge per E.S.F.U.:	\$105.00

With the non-metered debt rate established, the monthly charge for a residential property (one ESFU) connected to the Wightman's Grove Sanitary Sewer Improvement – Contract A (Wightman's Grove Area) is \$105.00. For multiple ESFU, the non-metered debt rate will be multiplied by the established ESFU determined for each connection.

Section 3: This resolution shall be certified to the Sandusky County Auditor and Sandusky County Sanitary Engineer.

Section 4: It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were so adopted in an open meeting of this Board, and that all formal actions, were in meetings open to the public, in compliance with all legal requirements.
